## VOLUNTARY ANNOUNCEMENT

### NEW LEASE AGREEMENT FOR THE OPENING OF A NEW SIU SIU CUEN RESTAURANT IN HONG KONG

This announcement is made by Taste · Gourmet Group Limited (the “**Company**”) on a voluntary basis with the aim of updating the shareholders and potential investors of the Company and its subsidiaries (the “**Group**”) on the latest business plan and development of the Company.

The board of directors of the Company (the “**Board**” or “**Directors**”) is pleased to announce that, the Group through a wholly owned subsidiary of the Company entered into a new lease agreement (the “**New Lease**”) for the opening of a new Restaurant under a new brand “Siu Siu Cuen” (小小串) in Hong Kong (the “**New Restaurant**”). Siu Siu Cuen is a Sichuanese provincial cuisine restaurant.

The New Lease is still subject to execution by the landlord.

The landlord is a major property developer and operator of premium shopping malls in Hong Kong. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, as at the date of this announcement, the landlord is an independent third party of the Company (as defined in the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) of the Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

#### **The New Restaurant, Siu Siu Cuen Restaurant at the K11 Art Mall, Tsim Sha Tsui**

The basic terms of the New Lease are as follows:

<b>Location:</b>	Shop B226 & B227A, Basement 2
<b>Lease Term:</b>	3 years with an option to renew for a further 3 years
<b>Lease Commencement Date:</b>	13 February 2023

The new restaurant is expected to commence operations in Q2 2023.

The terms of the New Lease were determined after arm's length negotiations between the Landlord and the Group, with reference to the prevailing market rentals for properties of similar type, age and location.

Located in the heart of Tsim Sha Tsui, the K11 Art Mall is managed by a major property developer in Hong Kong that also manages a diversified portfolio of investment properties.
