## **VOLUNTARY ANNOUNCEMENT**

### **NEW LEASE AGREEMENT FOR THE OPENING OF A YAKINIKU GUU RESTAURANT IN HONG KONG**

This announcement is made by Taste • Gourmet Group Limited (the “**Company**”) on a voluntary basis with the aim of updating the shareholders and potential investors of the Company and its subsidiaries (the “**Group**”) on the latest business plan and development of the Company.

The board of directors of the Company (the “**Board**” or “**Directors**”) is pleased to announce that, the Group through a wholly owned subsidiary of the Company entered into a new lease (the “**New Lease**”) for the opening of a new Yakiniku Guu Restaurant in Hong Kong (the “**New Restaurant**”).

The agreement in respect of the New Lease is still subject to execution by the landlord.

The landlord is a major property developer and operator of premium shopping malls in Hong Kong. To the best of the Directors’ knowledge, information and belief having made all reasonable enquiries, as at the date of this announcement, the landlord is an independent third party of the Company (as defined in the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) of the Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

#### **The New Restaurant, Yakiniku Guu Restaurant, Park Central, Tseung Kwan O**

The basic terms of the New Lease are as follows:

<b>Location:</b>	Shop 135, Level 1
<b>Lease Term:</b>	3 years with an option to renew for a further 3 years
<b>Lease Commencement Date:</b>	1 July 2025

The new restaurant is expected to commence operations in Q3 2025.

This will be the Group's fifth Yakiniku Guu Restaurant in Hong Kong.

The terms of the New Lease were determined after arm's length negotiations between the Landlord and the Group, with reference to the prevailing market rentals for properties of similar type, age and location.

Park Central, one of the largest and most well-established shopping arcades in Tseung Kwan O district strategically located adjacent to MTR Tseung Kwan O Station, Public Transport Interchange, and connected by bridges, making it a popular destination for both locals and tourists.
